(a) to provide pedal cycle parking spaces by replacing existing restrictions at the locations below:

Burghley Road: the south-east side, replacing the south-westernmost 5.5 metre section of the resident permit holders parking place at the side of Elsfield (No. 42 Highgate Road);

Erskine Road: the south-west side, replacing the north-westernmost 6.5 metre section of the shared use parking place outside No. 89b Regent's Park Road;

Fitzroy Road: the north-west side, removing the south-westernmost 7.5 metre section of the resident permit holders parking place outside 23 Chalcot Road to facilitate a 5.5 metre pedal cycle parking place and the placement of a traffic island to incorporate a tree;

Gordon Square: the north-east side of the south-western arm, replacing the south-easternmost 11 metre section of paid-for parking place opposite Euston Church;

Gordon Street: the north-east side, extend the existing pedal cycle parking place south-eastwards by replacing 5.5 metres of single yellow line outside 29 Gordon Street;

Harpur Street: the south-west side, replacing the south-easternmost 7 metre section of paid-for parking place at the side of No. 98 Theobalds Road;

Iverson Road: the south side, replacing an 11 metre section of resident permit holders parking place outside Nos. 208 and 210 Iverson Road;

King Henry's Road: the north-east side, extend the existing pedal cycle parking place south-eastwards by replacing 8 metres of car club parking place opposite The Chesterfields;

Netherhall Gardens: the south-east side, replacing the north-easternmost 5.5 metre section of the resident permit holders parking place opposite the side of 63c-I Fitzjohn's Avenue;

Nutley Terrace: the north-west side, extend the existing pedal cycle parking place at the side of 46 Fitzjohn's Avenue south-westwards by replacing 5.5 metres of resident parking place;

Osnaburgh Street: the south-east side, remove the existing 5.5 metre pedal cycle parking place at the side of No. 26 Longford Street, and provide a new pedal cycle parking place to replace the north-easternmost 12 metre section of resident permit holders parking place outside St Mary Magdalene Church;

Red Lion Street: the north-east side, extend the existing pedal cycle parking place:

- (i) north-westwards by replacing the existing paid-for parking place opposite No. 72 to 78 Red Lion Street; and
- (ii) south-eastwards by replacing the existing 'D' island and double yellow lines opposite No. 72 to 78 Red Lion Street;

Saffron Hill: the north-east side, extend the existing pedal cycle parking place north-westwards by replacing the business parking place at the side of Saffron Hill Car Park;

Shaftesbury Avenue: the north-west side, replacing 5.5 metres of loading place opposite No. 232 and 234 Shaftesbury Avenue;

Willoughby Road: the south-east side, replacing the paid-for parking place outside No. 80a Hampstead High Street;

Wilmot Place: the north-west side, replacing the south-westernmost 5.5 metre section of resident permit holders parking place at the side of No. 108 St Pancras Way;

(b) in King Henry's Road, on the north-eastern side, to:-

- (i) relocate the car club bay referred to above by replacing the south-easternmost 11.5 metres of resident permit parking place opposite Flat 12a, The Chesterfields; and
- (ii) replace the south-easternmost 3.5 metres of that car club parking place with a ban on waiting at any time (double yellow lines);

(c) in **Red Lion Street**, on the north-east side, remove the existing 5.5 metre disabled bay opposite no. 71 Red Lion Street (to be replaced with single yellow line) and replace it with a 6 metre disabled bay immediately south-east of the paid-for parking place opposite 68 to 70 Red Lion Street; and

(d) in Saffron Hill, on the north-eastern side:-

- (i) relocate the business parking place referred to above by replacing the south-easternmost 5 metres of resident parking place outside 60 to 66 Saffron Hill;
- (ii) provide a new resident parking place to replace 5 metres of double yellow line immediately north-west of the existing business parking place.

STATEMENT OF REASONS

The council has brought forward these proposals as part of our Healthy Streets approach, to provide high quality sustainable travel options for our community and make our streets a safe space for everyone to walk and cycle.

Camden is creating a network of Dockless Bike Hire and E-scooter bays across the Borough, providing dedicated locations from which these vehicles can be hired and returned. In most locations, these bays will be located on the road in place of parking spaces, to minimise impacts on the footway, and to further encourage switching from car ownership to the use of more sustainable modes of travel.

These proposals are a response to the high demand for micro-mobility (Hire bikes and E-scooters) in the borough which has created a need for additional space for hire vehicles to be parked. These proposals will help to ensure the bay network has the coverage across the borough and the capacity to meet this demand.
