Controlled parking zone 'CA-X' (Elm Village): experimental introduction of Saturday morning parking controls

The Camden (Parking Places) (CA-X) (Amendment) Experimental Traffic Order (No. 1) 2024 The Camden (Waiting Restrictions) (Amendment) Experimental Traffic Order (No. 1) 2024

- 1. Notice is hereby given that the Council of the London Borough of Camden ('the Council') on 11 July 2024 have made the above Orders under sections 9 and 10 of the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Orders would be, on an experimental basis:-
 - (a) to extend the hours of operation of all existing 'CA-X' permit holders' and paid-for or 'shared-use' on-street parking places, located in Barker Drive, Bergholt Mews, Blakeney Mews, Camley Street, Crofters Way, Ploughmans Close, Reapers Close, Rossendale Way, and Weavers Way, to include the period between 8.30 am and 12 noon on Saturdays; and
 - (b) to extend the hours of operation of existing 'single yellow line' waiting restrictions in the above-mentioned streets or parts of streets as lie within controlled parking zone 'CA-X' to include the period between 8.30 am and 12 noon on Saturdays.
- Copies of the Orders, which will come into force on 05 August 2025, and other documents relating to the Order may be obtained by contacting <u>traffic.orders@camden.gov.uk</u> or inspected either: online at <u>camden.gov.uk/recently-advertised-proposals</u> or by prior appointment, in person at 5 Pancras Square, London, N1C 4AG during normal office hours.
- 4. The Council will consider in due course whether the provisions of the Experimental Orders should be continued in force indefinitely by means of Orders made under sections 6, 45, 46, 49 and 124 of the Road Traffic Regulation Act 1984. Any person may object to the making of the Orders for the purpose of such indefinite continuation within a period of six months, beginning from the date on which the Experimental Orders came into force or, if the any of the Experimental Orders are varied by another Order or modified pursuant to section 10(2) of the 1984 Act, beginning with the date on which the variation or modification or the latest variation or modification comes into force. Any objection or representation must be in writing, quoting reference 'TMO2425-0001' and giving reasons for any objection and stating the grounds on which it is made, and sent to the e-mail address above or by post to 'FREEPOST LBC TRANSPORT STRATEGY', to be received by the end of 06 February 2025.

5. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within 6 weeks of the date on which the Orders were made, make application for the purpose to the High Court.

Statement of reasons

Controlled parking zone 'CA-X' (Elm Village): experimental introduction of Saturday morning parking controls

The Camden (Parking Places) (CA-X) (Amendment) Experimental Traffic Order (No. 1) 2024 The Camden (Waiting Restrictions) (Amendment) Experimental Traffic Order (No. 1) 2024

The Council of the London Borough of Camden propose to introduce an Experimental Traffic Order (ETO) for the introduction of Saturday controls as a trial between 8.30 am and 12 noon in CA-X Controlled Parking Zone (CPZ).

These measures are intended to help protect the existing parking provision for permit holders and to discourage inessential car journeys to the area on Saturdays by providing less parking opportunities for non-permit holders. During the trial period, feedback and monitoring data will be collected to inform the final decision as to whether this trial should be made permanent.

It is anticipated that the proposal will contribute to delivering a number of Camden Council objectives including:

- The Camden Transport Strategy (2019 2041) objective of reducing and mitigating the impacts of transport based emissions;
- The Camden Clean Air Strategy 2019-2034 which commits the Council to achieving the revised World Health Organization (WHO) air quality guidelines for NO2, PM10 and PM2.5 boroughwide no later than 2034.
- Camden Climate Action Plan, 2020 2025 vision of achieving a net zero Camden by 2030.

The ETO will be in place for 18 months. Monitoring data will be collected during this time to understand the impacts of the scheme on streets within the scheme area. The decision regarding whether or not to make the scheme permanent at the end of the trial will be based on monitoring data, feedback received during the trial period and Council policy and strategies.

Citation, commencement and expiry

1. This Order may be cited as the Camden (Parking Places) (CA-X) (Amendment) Experimental Traffic Order (No. 1) 2024, shall come into force on 05 August 2024 and will expire on 04 February 2026.

Interpretation

2. (1) In this Order:

"Council" means the Council of the London Borough of Camden;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme, or other instrument having effect by virtue of an enactment; and

"the Order of 2012" means the Camden (Parking Places) (CA-X) Traffic Order 2012², as amended.

- (2) Any reference in this Order to any other Order or enactment shall be construed as a reference to that Order or enactment as amended, applied, consolidated, re-enacted by, or as having effect by virtue of any subsequent Order or enactment;
- (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2012 shall have the same meaning as in that Order.

Amendment of the Order of 2012

3. Whilst this Order remains in force and without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2012 shall have effect as though in Schedules 1, 2 and 3 of that Order, in the fourth column ('controlled hours') of an item in those Schedules, for the words 'Monday - Friday 8.30 am - 6.30 pm, Saturday 8.30 am - 12 noon'.

Power to modify or suspend the provisions of this order

4. In pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Council's Director of Regeneration & Planning, Supporting Communities Directorate, or any person authorised in that behalf by them, if it appears to them or that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by this Order runs, may modify or suspend the Order or any provision therein, save that no modification shall make an addition.

EXPLANATORY NOTE

(This Note is not part of the Order)

This Order amends, by way of an experiment, the provisions of the Camden (Parking Places) (CA-X) Traffic Order 2012, so as to trial an extension of the hours of operation of parking places designated by that Order (that is, all permit holders' and paid-for or 'shared-use' on-street parking places within controlled parking zone 'CA-X') to include the period between 8.30 am and 12 noon on Saturdays.

- (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2012 shall have the same meaning as in that Order.

Amendment of the Order of 2012

- 3. Whilst this Order remains in force and without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2012 shall have effect as though:-
 - (a) for the items numbered 55, 90, 150, 236, 749, 789, 820 and 975 and set out in Schedule 1 to that Order there were substituted the items set out in Schedule 1 to this Order; and
 - (b) there were added to Schedule 1 to that Order the item set out in Schedule 2 to this Order.
